

Westbrook Spring Arts & Crafts Fair 2017

The WDTC **Twenty-Ninth Annual Westbrook Spring Arts & Crafts Fair** will be held on **Sunday, June 4, 2017** from 10:00 a.m. to 4:00 p.m., rain or shine, on the Westbrook Town Green. The Green is located in the center of town at the intersection of Routes 1 and 153, just off Exit 65 of I-95, and less than a mile from the Tanger Outlets in Westbrook. The site has high visibility; there is ample parking around the Green and across the street; and there is no admission fee for the public.

Entries are limited to **original, handcrafted or hand produced items**. All entries must be fully described on the Application Form and **photos must be submitted**. Photos should clearly show representative items as well as overall booth appearance. For jewelry, we also require a workroom picture (this requirement cannot be waived). Jury decisions will be based upon the exhibitor's primary craft; secondary crafts will be allowed only if included on the application and not deemed duplicative of another's primary craft. Any hands-on children's activity must be identified as such. All exhibits must be professional in appearance and all tables must be covered. Any exhibitor whose booth does not comply with the above standards or whose art/craft is not deemed to be as represented on his/her application will be asked to leave and no refund will be given. Exhibitors shall not hold the WDTC liable for damage to any items displayed at the event.

Cars will be allowed on the Green only during set up (beginning at 7:00 a.m.) and take down. Parking will be available nearby during the day. The standard site size is 12' x 12'; a "site-and-a-half" may be reserved for an additional fee.

Please complete the attached Application Form and return it with the required site fee and appropriate photo(s). First jury date is April 1, 2017 with responses mailed by April 15. Second jury date for remaining spaces is May 1. It is not uncommon for certain categories to meet quota and close after the first jury date. If spaces remain after May 15, a late fee of \$5 is added to the application fee. Site fees will be returned after the jury date to any exhibitors who cannot be accommodated. Exhibitor photos will not be returned until after 1:00 p.m. on June 4.
